## THE 2020 CENSUS IS COMING SOON

In mid-March, homes across the country will begin receiving invitations to complete the 2020 Census. Once the invitation arrives, you should respond for your home in one of three ways: online, by phone, or by mail. Please take note of the following time line.

- ◆ **March 12 - 20:** Households will begin receiving official Census Bureau mail with detailed information on how to respond to the 2020 Census online, by phone, or by mail.
- ◆ **March 30 - April 1:** The Census Bureau will count people who are experiencing homelessness over these three days. As part of this process, the Census Bureau counts people in shelters, at soup kitchens and mobile food vans, on the streets, and at non-sheltered, outdoor locations such as tent encampments.
- ◆ **April 1:** Census Day is observed nationwide. By this date, every home will receive an invitation to participate in the 2020 Census. Once the invitation arrives, you should respond for your home in one of three ways: online, by phone, or by mail. When you respond to the census, you'll tell the Census Bureau where you live as of April 1, 2020.
- ◆ **April:** Census takers will begin visiting college students who live on campus, people living in senior centers, and others who live among large groups of people. Census takers also begin conducting quality check interviews to help ensure an accurate count.
- ◆ **May - July:** Census takers will begin visiting homes that haven't responded to the 2020 Census to help make sure everyone is counted.
- ◆ **December:** The Census Bureau will deliver apportionment counts to the President and Congress as required by law.

### AVOID FRAUD AND SCAMS

The U.S. Census Bureau is committed to making the 2020 Census quick, easy, and safe for all participants. Here are some tips to help you stay safe:

- ◆ **Avoiding Scams Online;** Phishing is a criminal act in which someone tries to get your information by pretending to be an entity that you trust. Phishing emails often direct you to a website that looks real, but is fake, and may be infected with malware.  
  
It is important to know that the Census Bureau will not send unsolicited emails to request your participation in the 2020 Census. Further, during the 2020 Census, the Census Bureau will never ask for:
  - \* Your Social Security Number.
  - \* Your bank account or credit card numbers.
  - \* Money or donations.
  - \* In addition, the Census Bureau will not contact you on behalf of a political party.

If someone visits your home to collect a response for the 2020 Census, you can do the following to verify their identity:

- ◆ First, check to make sure that they have a valid ID badge, with their photograph, a U.S. Department of Commerce watermark, and an expiration date.
- ◆ If you still have questions about their identity, you may call 800-923-8282 to speak with a local Census Bureau representative. If it is determined that the visitor who came to your door does not work for the Census Bureau, contact the Police Department at (270) 877-2252.

### THE CENSUS BUREAU PROTECTS YOUR INFORMATION

The U.S. Census Bureau is bound by law to protect your answers and keep them strictly confidential. In fact, every employee takes an oath to protect your personal information for life.

The Census Bureau is bound by Title 13 of the U.S. Code to keep your information confidential.

Under Title 13, the Census Bureau cannot release any identifiable information about you, your home, or your business, even to law enforcement agencies. The law ensures that your private data is protected and that your answers cannot be used against you by any government agency or court.

The answers you provide are used only to produce statistics. You are kept anonymous: The Census Bureau is not permitted to publicly release your responses in any way that could identify you or anyone else in your home.

Being responsible stewards of your data is not only required by law, it is embedded in Census Bureau culture. Strict policies and statistical safeguards help protect the confidentiality of your information. Before releasing data products, the Census Bureau verifies that they meet its confidentiality standards.

### **SAFE ROOM AVAILABLE TO ALL CITIZENS**

Citizens who do not have access to a basement or any other protection during severe weather are encouraged to take advantage of the safe room, which is located at the Vine Grove Fire Department, at 513 Highland Avenue.

The Safe Room was constructed to accommodate approximately 500 people, on a short-term basis. It is not intended to be a long-term shelter, but it will give refuge during extreme weather events.

Citizens need not wait for someone to be on the scene to open the doors, as the doors may be unlocked remotely by Fire Chief Steve New. The moment he receives notification that severe weather is on the way, he can unlock the door remotely, thereby allowing citizens immediate access to safety.
