LATE FEES FOR WATER BILLS TO BE REINSTATED

Due to the COVID crisis, and the guidelines set forth by Kentucky's Governor Beshear, the City of Vine Grove has not charged late fee penalties since March of 2020. However that is about to change.

According to executive order # 2020-881 issued on October 19, 2020: All entities that provide natural gas, water, wastewater or electric service within the Commonwealth, including, but not limited to entities created under KRS Chapters 96 and 279, shall continue to waive assessment of late payment fees for residential customers through **December 31, 2020**.

Therefore, beginning in February, the City of Vine Grove will resume assessing late fees for water bills not paid by the 10th of each month. Disconnections for non payment was reinstated in December.

CITIZENS ASKED TO USE CAUTION WHEN FLUSHING

Citizens are asked to be aware that flushing items such as napkins, paper towels, T-shirt fabric, rubber/plastic gloves, feminine hygiene products, and even baby wipes that say they are flushable, are hazardous to the system.

Often times, when plumbers, or Public Works has to be called for a sewer back-up, the resident will say that the items they flushed said they were flushable on the package. What it *doesn't* say on the package, is that even though the item may go down when flushed, there is no guarantee that it won't clog the sewer pipes.

Please keep a bag-lined waste can next to your toilets, and dispose of these items in that can. Anything other than human waste and toilet paper will most likely clog the sewer lines and pump stations, causing a back-up, which could affect your homes.

It is so much easier to use this preventative approach, than it is to clean up the mess caused by a sewer back-up.

CITY DISCUSSES SNOW REMOVAL

Winter has officially arrived, meaning colder weather, and the chance of snow and sleet. That means that City workers must be on alert for inclement weather, and they must be prepared to spread salt and plow roads.

Because it is impossible to schedule for bad weather, our crews are on constant stand-by during winter months, to ensure that our roads are cleared and ready for citizens to drive on them.

We are asking for your help:

- ◆ Refrain from parking vehicles on the street. Vehicles parked in the street hinder snow plows from doing their job.
- ◆ Whenever possible, refrain from driving on unplowed roads. Driving on fresh snow packs it down, often causing the plow to skim over the top, rather than clearing the snow, and the packed snow tends to become ice.
- ◆ Be patient, the City has a limited number of snow plows, and our crews will get to every street just as quickly as possible
- ◆ Please understand that our crews are doing their best. However, when they plow roads, they cannot prevent the snow from going into driveways, or from blocking mail boxes.



CITY OFFERS REASONS TO CARE ABOUT STORMWATER

We are all part of a watershed. Watersheds are land areas that drain to the nearest body of water. For example, if you are in western Pennsylvania, you are part of the Ohio River watershed, while eastern Pennsylvania lands may ultimately drain to the Chesapeake Bay. Smaller local creeks and streams also eventually drain to a larger local water body.

Flooding

When excess water has nowhere to go, flooding can impact property and cause damage to land and structures. Flooding can also be a public safety issue that affects entire communities.

Pollution and Health Impacts

Stormwater picks up anything that is on the ground and carries it along with it. Animal waste, chemicals, pesticides, oil, and sediment – all end up in waterways and potentially in our sources of drinking water.

Streambank Erosion

Uncontrolled stormwater can cause streambank erosion, leaving bare soil and exposing tree roots. This can lead to property damage and cause issues with streambank stability.

Sedimentation

Erosion and runoff, can also lead to sedimentation. Sedimentation of waterways from runoff causes changes to aquatic habitats. Undesirable plant growth increases, water becomes more turbid or cloudy, which leads to disruption of aquatic ecosystems. Sedimentation also fills in waterways, which can increase the flooding potential.

Impacts to Groundwater Recharge

If stormwater isn't sinking into the ground it can affect recharge of groundwater resources. This can affect water levels in drinking water wells as well as impacting levels in surface water.

Impacts to Recreational Opportunities

Stormwater runoff can cause polluted waterways which can lead to restrictions on boating, swimming, and fishing in recreational areas.

Making changes to how stormwater is managed can go a long way to reduce negative impacts. Even small actions by individual homeowners like using a rain barrel, choosing permeable landscaping surfaces, or installing a rain garden can make a difference. Stormwater affects everyone!

CITY COUNCIL AND PLANNING AND ZONING MEET MONTHLY

City Council meets on the first Monday, of every month at 6:30 p.m. in the new Council Chambers, located in the former meeting room #1.

The Vine Grove Planning and Zoning Commission meets on the third Monday of every month at 6 p.m., also in the Council Chambers.

Exceptions for both bodies occur whenever a federal holiday falls on the regular meeting date. In that event, the meeting is held on the following Monday. All meetings are open to the public and citizens are encouraged to attend.
